The Promoter & Contest Details

The Promoter of this contest is the Palau National Communications Corporation (PNCC) located in Airai, Palau. This contest is managed by (Agency) Big Fish Creative, Inc. an authorized agent for PNCC.

In celebration of its 38th Anniversary in Palau, PNCC is hosting this video contest for its customers.

Entry Instructions*:

1. Download the PNCC jingle(s) at www.pnccpalau.com/contest
2. Create a fun and unique short video using the PNCC jingle (in Palauan or English)
3. Post your video on Facebook and tag PNCC @connectingpalau
4. Share your video post with your friends for engagement – these counts as votes

Eligibility

This contest is open only to residents of Palau. Participants must be 13 years old to enter. PNCC employees and their immediate family are not eligible to enter.

Contest Period

The video contest begins on September 4, 2020 and ends September 29, 2020.

PNCC’s “38th Anniversary Video Contest” Participants are tasked to produce a creative video, lip-dub, or slideshow using one (1) of the PNCC jingles in Palauan or English lyrics. Participants can use any video creation/editing programs or app of their choice (example TikTok or iMovie). Participants are encouraged to use handset mobile devices to record their video and audio

Entries must be made by the Participant and must not be made through agents or third parties.

Entry Instruction Details

By uploading your video on Facebook and tagging Palau National Communications Corporation (PNCC), participants are officially entered.

1. Participants have 2 weeks to produce their video, after contest’s launch.
 - For their use and production, participants are responsible to download the PNCC jingle audio file from the PNCC website (<https://www.pnccpalau.com/contest>).
 - 2006 edition in Palauan (MP3 format)
 - 2006 edition in English (MP3 format)
 - 2017 edition in Palauan (WAV format)
 - 2017 edition in English (WAV format)
2. Participants have until Tuesday, September 22nd to post their video on their (personal) Facebook page and tag PNCC in the caption for official entry.
 - Participants may enter more than one (1) video. Each entry will be judged separately.
 - Participant’s Facebook page must be set on public for viewing.
 - PNCC is not responsible for unsuccessful uploads or corrupted files online.
 - Participants are not limited to post by the September 22nd deadline. They are encouraged to post their video as soon as possible, for chances to gain “votes”.
3. Participants must tag PNCC (@connectingpalau or Palau National Communications Corporation) and must use the following hashtags in their caption #connectingpalau #pncc38years. Optional: video post caption can advise the model of the device used to record the video, for example: “Recorded with an iPhone 11 Pro Max”.
4. Video entries and video post captions must not contain any profanity or negative comments as determined by PNCC’s review. Entries subject to this will be withdrawn immediately.

The entries will go through an approval process as established by the Promoter. The Promoter's decision is final in the determination of a winners and a substitute winners, should the winner be deemed ineligible to win the Prize.

Voting Process

- The winning video is determined by the number of engagements (via likes/reactions, shares, and comments). Each engagement is counted as a "vote". The video with the most "votes" wins.
- Participants are encouraged to tag their friends and families to encourage more chances of "votes".
- "Votes" only count towards the original video posted on the Participant's Facebook page. Comments and other engagements from shared videos via another party will not count as a "vote".

Winner Selection

Winners will be determined on Wednesday, September 30, 2020. Once the Winners are notified, they will have 2 business days from the date the notification was sent them to respond, and up until 1 week to claim their Prize via the contact information provided to them.

In the event that a Winner or substitute Winner is unreachable, ineligible, or fails to claim the Prize in the time required, the Winner or substitute Winner shall forfeit their prize and it will be awarded to a substitute Winner, which shall be the next Entry selected in accordance with the selection process above.

In the event that a Grand Prize Winner or substitute Winner is younger than 18 years old, the subscription must be made in their parent's or guardian's name. Said parent/guardian must be present to claim and register the Grand Prize for/on behalf their child.
